**AGREEMENT**

The Baltimore Area American Flyer Club and the Washing and Old Dominion S Gaugers, here after identified as NASG17, agrees to provide Manufacturer, Dealer or Exhibitor ("Exhibitor") with table space in the exhibit area of the 2017 National Association of S Gaugers ("NASG") Convention in Timonium, Maryland subject to the following terms and conditions:

1. Table space reservations will be processed on a first-come, first-served basis. When available, table space has been fully reserved, NASG17 will place additional exhibitor requests on a waiting list, but makes no guarantee they can be honored.
2. Exhibitor shall pay all fees at time of registration. Each exhibitor **must register for the convention and must be an active paid member of NASG**. A registration without a fee will not be processed until the fee is tendered. If a check is dishonored, NASG17 will void the registration.
3. Exhibitor will not sub-lease the space nor any part thereof.
4. Collection and remitting of sales tax will be the sole responsibility of the exhibitor. Sales tax in Maryland is 6%.
5. Private Raffles by the exhibitor are expressly forbidden.
6. NASG17 will provide six foot tables with table covers and 1 chair per table, unless exhibitor indicates that a table is not needed.
7. If a space with power is reserved, NASG17 will provide power to the space. Exhibitor shall provide its own long heavy-duty extension cord(s).
8. If NASG17 provides loading/unloading assistance upon exhibitor's request, exhibitor will hold NASG17 harmless from any and all damage which might occur as a result of such assistance.
9. Exhibitor will remain for the entire length of the show, and will abide by the exhibitor hours set by NASG17.
10. Exhibitor agrees to comply with all terms and conditions established by NASG17 for its convention, and all laws of the State of Maryland.
